The bidding firm should have a minimum of 5 years' experience of construction services with maintenance support, preferably with Government, Semi-Government and autonomous bodies (attach relevant evidentiary documents) and provide outline of similar assignments mentioning description, client, location, duration, start & finish dates and approximate value of such services.
- 5. The bidders must ensure that their technical proposal follows the Pakistan Building Codes.
- 6. The bidding firm should not be blacklisted by any public or private sector organization (attach an affidavit).
- 7. In case the bidding firm so wishes, site visit may be arranged upon written request.
- 8. All documents submitted by the bidder must be duly signed by the bidder/authorized representative and should have a Company Seal on them.
- 9. QA Solar will not be responsible for any costs/expenses incurred by the bidders in connection with preparation or delivery of bids.
- 10. Rated quotes should be in Pak Rupees, inclusive of all applicable taxes. If not specifically mentioned in the quotation, it will be presumed that the prices include all the taxes. These rates quoted shall remain valid for a period of 12 months.
- 11. The successful bidding firm shall be expected to provide performance security amounting to 2% of the Contract Price, in the shape of non-recourse, irrevocable and unconditional bank guarantee from a scheduled bank of Pakistan.

- 17. If the technical proposal of any of the bidding firms does not fulfil the aforementioned criteria and/or the TORs (**Annexure-A**), they will be considered non-responsive and their financial bids will be returned unopened.
- 18. Late received bids will be returned unopened. No alteration/amendment shall be allowed after submission.
